# 72<sup>nd</sup> Hong Kong Schools Speech Festival - English Speech Circular No. 6

# To : Members / Teachers Responsible for the Speech Festival

## Date : 24 November 2020

In view of the latest surge of COVID-19 cases, the government has once again tightened the epidemic control measures. The Education Bureau has announced the corresponding face-to-face class suspension. We understand that schools and teachers are facing multiple constraints and challenges.

In an effort to allow teachers and students ample time to prepare for Speech Festival and Music Festival during the epidemic, in the early stage of planning the Festivals, the Association has postponed the enrolment deadlines. As a result, the Association has compressed the work schedules of collecting the video URLs, dissimilating the URLs to local and overseas adjudicators, adjudicating and compiling comments etc. The 95 adjudicators will begin their adjudication on almost 70,000 videos starting December 2020. In order to distribute the mark sheets and certificates to the competitors in time, there is simply no room for the Association to make further postponement on the Festival schedule.

The "Video Submission Mode" is designed such that competitors can perform without the limitation of location and time. They have to record their performance with a device as simple as a mobile phone and submit the video URL within the submission period. During this difficult period, the Association hopes to provide learning experience through art and support for the participating students, teachers and parents. Members and teachers responsible for the Speech Festival please pay attention to the following:

#### 1. <u>Support from the Association</u>

#### 1.1 Technical Support Centres

The Association has set up some technical support centres to assist competitors who have difficulties in uploading videos and filling the on-line submission form (note: no video recording service will be provided). This service will last until the end date of video URLs submission, i.e. 30 November 2020 (5:00 p.m.). In line with the crowd control measures at the centres, members/ parents / competitors have to register for the service in advance on the Association website. Each Reference Number on Competition Notification can be used to make one booking. For details, please refer to the Association website.

#### 2. <u>Video URL Submission</u>

Competitors are required to upload their videos to YouTube, and then fill out and submit the Video Submission Form. Deadline for the submission is **30 November 2020** (5:00 p.m.). The on-line Video Submission Form is now accessible from the Association website. Any late submission, regardless of reasons, will not be accepted.

#### 3. <u>Submitting On-line Video Submission Form</u>

- 3.1 When filling out the Form, please make sure the Reference Number and Validation Code match the information in the Competition Notification (CN). Otherwise, the submission record will become invalid and the video will not be judged. The Association will not notify individuals if such case arises.
- 3.2 After submitting the Form, the competitors will receive an auto-reply confirmation email, with a copy of the submitted information. Members / competitors must check the accuracy of the information in the email. If any error is found, or no email has been received, please submit the Form again within the submission period.
- 3.3 Members please pay special attention to the below common errors when submitting the Form:
  - •Mistook the Membership Number (6-digit number) as the Reference Number (8-digit number)
  - Typo in entering the Reference Number (8-digit number)
  - Typo in entering the Validation Code (6-digit alphanumeric character)
  - •Typo in entering the YouTube URL
  - •Did not upload the video to YouTube / the URL inputted was not a YouTube video URL



## 4. <u>Report of Video Submission Status</u>

To help members follow up and acknowledge the status of the video submission of the participating students, the Association will compile the submission records and upload reports to Member's Area on the Association website on the following dates:

- \*4:00 p.m. on 26 November 2020– This is an **interim** report as at noon of 26 November 2020. If there is any problem with the submitted information, please submit the Form again before the deadline. If the Association has no submission record, please remind the participating students to submit before the deadline.
- 10:00 a.m. on 4 December 2020 This is the **final** report. As the submission period has ended, any special request or alteration regarding the submission will **not be considered.**
